PENNSYLVANIA, PROVIDING: DEFINITIONS,
PROCEDURES, DESIGN STANDARDS,
REQUIRED IMPROVEMENTS, PLANS AND REPORT, MAINTENANCE
AGREEMENTS, FEES AND PENALTIES FOR ANY PERSONS WHO
FAIL, OR REFUSE TO COMPLY WITH THE
REQUIREMENTS AND PROVISIONS OF THIS
ORDINANCE.**
